REFUGEE SERVICES: DESPITE THE CONTINUED IMPACT OF COVID-19 ON THE ABILITY OF REFUGEES TO COMPLETE OVERSEAS PROCESSING AND TRAVEL, SACRAMENTO CONTINUED TO SERVE SIGNIFICANT NUMBERS OF NEWLY ARRIVED REFUGEES IN 2020, PREDOMINANTLY SPECIAL IMMIGRANT VISA HOLDERS FROM AFGHANISTAN. IN 2020, WE PROVIDED REFUGEE RESETTLEMENT SERVICES TO 560 INDIVIDUALS. THIS NUMBER CONSISTED PRIMARILY OF AFGHAN SIV HOLDERS, BUT ALSO INCLUDED SOME IRAQI, SYRIAN, UKRAINIAN AND REFUGEES FROM OTHER COUNTRIES OF ORIGIN.
