Our mission is to enrich communities by supporting immigrants, refugees, and survivors of trafficking on their path towards stability, self-sufficiency and belonging.

Ideal candidate: The ideal candidate is organized, proactive and solution-oriented, with strong project management and communication skills.

They will have the ability to work effectively in multi-cultural work environments, showing respect and sensitivity for cultural differences, and will be passionate about Opening Doors' mission.

Responsibilities: The essential duties and responsibilities of this position include the following:

- Serves as frontline in-house IT problem solver and refers work to IT professionals as appropriate.
- Oversee the maintenance of technical documentation for an accurate inventory of all hardware and software items, including documentation related to their installation, registrations, passwords, codes or other elements essential to their configuration and operation.
- Purchase or consult on purchase of computer systems and software applications, with the Director of Operations.
- Install new computer systems, maintain installed systems, and troubleshoot end user problems.
- Provide support to employees at the office or remote work site. Ensure that requests for technical support are resolved promptly and courteously.
- Cover the reception area when the Administrative Assistant is on leave or on breaks.
- Regularly assesses the physical condition of the office, procedures and orders necessary repairs.
- Track and maintain the assets and office supplies.

- Ensure timely ordering of supplies, ensures that clerical functions are properly assigned, monitored and completed.
- Assist Director of Operations with check requests preparation, and maintaining petty cash.
- Assist Director of Operations and HR Manager with any other HR and Operations related tasks.

Other duties may be assigned in the sole discretion of the Organization. The Organization may assign or shift duties and responsibilities to this position at any time due to reasonable accommodation or other reasons.

Required Qualifications: The requirements listed below are representative of the knowledge, skills and/or abilities required.

- Operating systems: Windows 10 and Vista, MS Word, MS Access, and MS Excel
- Web-based technologies: Office 365, Google Applications, , and VPN.
- Troubleshooting: Installing, and configuring external peripheral devices including but not limited to printers, modems, fax modems, and scanners.
- Installation and Configuration: Installing, and configuring computer workstations. Troubleshooting and configuring electronic communications including email, fax, data transfer devices and telephones.
- High levels of attention to detail and demonstrated ability to adhere to organizational policies and procedures.
- Familiarity with clerical, administrative or operational office support.
- Ability to collaborate effectively with colleagues in different departments and roles within the organization while maintaining confidentiality.
- Possession of a valid driver's license and vehicle insurance.
- Demonstrate ability to work effectively in multi-cultural work environments.

Preferred Qualifications: The requirements listed below are not required but are desired.

- Significant experience with clerical, administrative or operational office support.
- Familiarity with the social services or nonprofit fields.
- Demonstrated experience with Adobe, DocuSign, Heartland, Salesforce, and/or Donor Perfect platforms.
