THIS NUMBER CONSISTED PRIMARILY OF AFGHAN HUMANITARIAN PAROLEES EVACUATED DURING THE US WITHDRAWAL FROM AFGHANISTAN, BUT ALSO INCLUDED SOME IRAQI, AFGHAN, UKRAINIAN AND REFUGEES FROM OTHER COUNTRIES OF ORIGIN. WE PROVIDE ASSISTANCE IN SECURING HEALTH CARE, HOUSING, AND OTHER SERVICES DURING THE FIRST 90-DAY ARRIVAL PERIOD. WE ARE FORTUNATE TO HAVE STRONG SUPPORT FROM VOLUNTEERS, LOCAL FAITH COMMUNITIES, AND DONORS THAT HELP US ENSURE THAT ADULTS RECEIVE ESL AND EMPLOYMENT SERVICES, AND CHILDREN ARE ENROLLED IN SCHOOL AS WE WELCOME THEM TO OUR COMMUNITY.
